

The above published merit list shall be guided by the following norms and condition as resolved by the D.L.S.C., Purulia.

- a) The selected candidates shall be appointed purely on temporary basis and shall remain on probation for the period as provided in statute. During his / her period of probation, if it is found that the candidate is not fit for the post then his/ her period of probation shall not be extended and he /she will be removed from this post / service.
- b) The selected candidates who are already in Government Service either in any department of Govt. of West Bengal or Union of India or any other state within India, he /she shall submit a certificate issued by his / her appointing authority showing that there is no disciplinary proceedings pending against him / her for the charge of corruption, insubordination or for any other reason and there is no criminal case arising out of his / her rendering present service is pending or any other proceeding is pending against him / her.
- c) The candidates shall submit the certificate as mentioned in point 'b' along with the filled up police-verification-roll. Non-submission of such certificate shall be treated as violation of the norms of the selection. -
- d) The successful candidates shall download the police-verification-roll from the official website of Purulia-district(www.purulia.nic.in) . He / she shall submit duly filled up police-verification-roll(two-copies) along with duly attested copies of his / her all educational qualification related documents and other related documents within 28-10-2016 to the P&RD section of the office of the undersigned.

- e) In case of suppression of any educational qualification or any other information by the candidates during submission of the police-verification-roll will be dealt with as per existing laws .
- f) The candidates shall not have any right to claim the post only on the ground that his / her name has been published in the category of selected candidates.
- g) This recruitment committee as well as appointing authority shall reserves their right to de-list any candidate from the list of successful candidates if it is found that otherwise the candidate is not suitable for the post.
- h) The selected candidates will have to appear before the Medical Board in the Office of the Chief Medical Officer of Health, Purulia at the date & time to be intimated later.
- i) Non – submission of police verification roll and non-appearance before the medical board will be treated as unwillingness to join his / her post offered and will lead to make the successful candidates deleted from the list of selected candidates.
