ENGAGEMENT NOTICE

Applications are hereby invited from Indian citizens and willing candidates for engagement to various contractual posts under Rastriya Swasthya Bima Yojana(RSBY) with age not more than 40 years as on 01.01.2018(Upper age limit is relaxable for the candidate belonging to categories of schedule caste , schedule tribe and other backward classes as per extant government order) in accordance with Memo no. HF/O/MS/W-03/PART-II/Part file /1165 date:16.12.2014 of the Health and Family Welfare Department, Government of West Bengal.

Eligibility criteria for the various contractual posts and other conditions along with procedure of application and other processes for selection for engagement are given as follows. The posts are purely contractual in nature and initial engagement will be made for 1 (One) year which may be renewed as per satisfactory performance of the incumbent.

A. Details of Contractual Posts with Remuneration & Eligibility Criteria.

B. For selection of the District Co-ordinator Hospital post, candidates will have to appear in a written examination of 75 marks, computer test 20 marks, and Personal interview 5 marks. For selection of the District Co-ordinator IT post, candidates will have to appear in a written examination of 70 marks, computer test 25 marks, and Personal interview 5 marks.

C. Grounds for Rejection of Applications:-

1. One candidate can submit only one application under one category of post. Submission of multiple applications for the same category of post is not allowed. More than one application submitted for the same category of post shall be liable to be rejected.
2. Online generated application forms if submitted without the copies of essential documents as mentioned above shall be summarily rejected.
3. Application will also be rejected if there is data mismatch in the filled in application form with reference to the soft copies of the documents submitted.

After due scrutiny of eligibility as per notice, short listed candidates will be called for written examination.

Other Terms and Conditions:-

1. Submission of online application:- The willing candidates are instructed to visit the district portal www.purulia.nic.in where selection notification will be made available from 12.11.2018 for filling online application.
2. Last date of submission of online application is 26.11.2018 up to 5.00 pm.

3. Willing candidates shall have to upload the scan copy of valid Id proof, valid age proof, caste certificate (if applicable), credentials for essential education qualification, diploma (or Computer Application) Certificate/Diploma or Post Graduate Diploma in Business Management or Administration Certificate, Photo and Signature. After successful submission of online application, a dynamic form showing the details of the candidate along with the photo and signature will be generated. Candidates are instructed to keep a printed copy of the form for record purpose. Also, after successful submission of online application a unique Registration No. will be generated. Candidates are instructed to remember that Registration No. for future reference.
4. All applicants should contain the original scan copies of all testimonials to substantiate eligibility in respect of Essential Qualification & Residence and also to establish desirable Qualifications.
5. Under no circumstances offline application will be accepted. A candidate must go through the instruction thoroughly and carefully before submitting online application. Any omission/suppression of information shall lead to rejection of application or candidature at any stage of the process without further intimation.
