NOTIFICATION

Considering the steady increase of COVID-19 cases in Purulia Municipality in recent past and in pursuance of the Order No. 177-CS/2020 dated 18/05/2020 by the Hon'ble Chief Secretary, Government of West Bengal and order no. 351/HS/PA/20 dated 7th July, 2020 of Additional Chief Secretary, Home & Hill Affairs and P.A. Deptt. Government of West Bengal regarding notification of Containment Zone related to outbreak of COVID-19 in Purulia District,

the following area of Tika Para in Munsiffdanga, under Ward No. 2 of Purulia Municipality are hereby declared as broad based Containment Zone.

1. House of SK Sajjad to House of SK Rahim where extended containment zone Management will be enforced for the period of 14th days i.e. 10th August, 2020 to 23rd August, 2020 with following restrictions:-

All necessary standard operating procedures with the following shall be strictly adhered to:


1. No Socio-economic activities permitted.
2. Complete access control. Cordoning of the entire unit with complete restriction on ingress and egress.
3. Regular sanitization / cleaning by Purulia Municipality.
4. Dedicated suitably equipped task force for conducting outreach fever mapping and enforcement of restrictions imposed. Intensive testing and contact tracing.
5. Organizing home delivery of essential commodities, medicines and health services, as per need.
6. Appropriately equipped with protective cover e.g. PPEs, masks front line workers will do intensive home surveillance.
7. This broad based containment zone will be subjected to strict lockdown, and the following activities, inter alia, will be closed in this area:
 - i. All offices, government and private
 - ii. All none-essential activities

- iii. All congregations
 - iv. All transportation
 - v. All marketing/ industrial/ trading activities
8. Residents of the containment zones will be exempted and prohibited from attending government and private offices. In fact, their ingress and egress will be strictly regulated.

The orders to be issued by State Govt. time to time regarding COVID-19 management will be complied strictly.

All concerned are hereby informed accordingly.





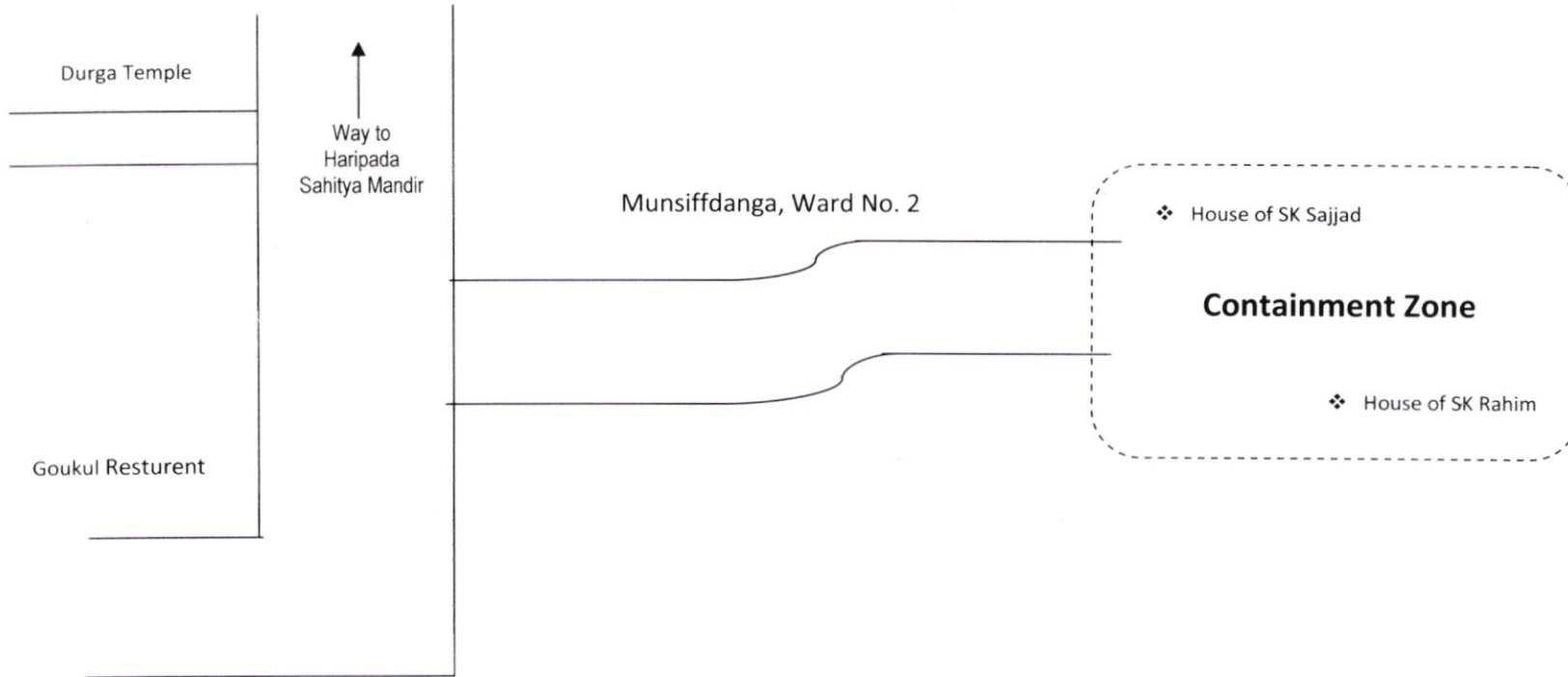
