- Earnest money to be deposited in favour of the Collector, Purulia through netbanking/NEFT.
- Technical bid will be consisting of following document.
  - Valid Income Tax Clearance Certificate & PAN, for the last current year.
  - Valid 15 digit goods and service Taxpayer Identification No. (GSTIN).
  - Credential Certificates of Similar nature of works executed in last 5 years only.
- The Financial Bid should contain the rate offered by the agency as per schedule of works.
- Technical Bids will be opened at 16:30 Hours on 02/04/2018 in the Office of the Land Acquisition Department, Purulia. Financial Bid will be opened on the technically qualified bidders will be notified later on after evaluation of technical bid.
- The bidder should quote their offer percentage less/above/at per in the specified format of BOQ given in financial bid only.

9. The bid for the work shall remain open for acceptance for a period of 30 days from the date of opening of bids. If any bidder/tenderer withdraws his bid/tender before the said period or makes any modifications in the terms of conditions of the bid, the said earnest money shall stand forfeited.
10. The Additional Performance Security shall be obtained from the successful bidder if the accepted rate is more than 20% less than tender amount. The additional performance security shall be equal to 10% of tendered cost and to be submitted in the form of Bank Guarantee from any Scheduled Bank within 7 (seven) days from issue of acceptance of letter, failing which deposited earnest money will be forfeited. Validity of performance security should be up to one month more than completion period. In case of non completion of work within scheduled time, the additional performance security will be forfeited.
11. Other details can be seen in the bidding documents.
12. Work is to be completed within 30 days from the receipt of work order.
13. Validity of bid will be 180 days.
