Conditions:

1. Fuel for the vehicle will be supplied by the District Mid-Day Meal Cell as per Govt. Rate. Fuel allowed for hiring is 1 litre Diesel per 10 k.m. & 1 litre Mobil per 500 k.m. or as per order of the Transport Dept., W.B.
2. The driver will be provided by owner and driver has to be familiar with roads of Purulia & Kolkata. All the repair and maintenance, taxes, fees & fine and pay of driver in respect of vehicle will be borne by the owner.
3. The vehicle owner will have to arrange Garage facility by his own cost.
4. The vehicle should be maintained in excellent condition and should abide by all the norms of plying commercial vehicle(Insurance, Road Tax, Pollution Clearance, Fees, Fines etc) as laid down by the Transport Department, Govt. Of WB.
5. The vehicle owner will be responsible to ensure the availability of vehicle on all days that the vehicle is asked to report for duty including holidays, if need be. Alternative arrangement of vehicle has to be done within a short period by the owner in case of breakdown of vehicle. Substitute driver is to be provided by the owner in case of absence of regular driver.
