NOTICE INVITING QUOTATION

Sealed quotations are hereby invited from intending bonafide agencies for webcasting in respect of First Level Checking of EVMs & VVPATs in connection with ensuing Lok Sabha General Election' 2019 for The District of Purulia subject to following terms and condition as noted below:

Terms & Conditions:-

Intending agencies shall submit quotations together with the following requisite documents:

- A) GST Registration Certificate,
- B) Photocopy of Income Tax Return during the last year & PAN No,
- C) Photocopy of Trade Licence,
- D) Photocopy of Professional Tax Clearance Certificate,
- E) Credential Certificate of similar nature of works during the last three years etc.,
- F) Earnest Money amounting to Rs. 2000/- (Rupees Two Thousand) only in the form of bank draft in favour of the District Magistrate & District Election Officer, Purulia,

Rate should be quoted both in figures and words & must be inclusive of GST as per norms.

The work is to be done on emergency basis with the installation of eight (7+1) IP Cameras, 16 port NVP, 16 port switch, 2 coil wire (CAT6), one UPS (1KVA), wall rack and 2(two) TB surveillance HDD to be completed within the stipulated time as will be mentioned in the work order.

No photocopy of documents will be allowed at the time of verification of documents.

Successful quotationers will be given execution order only after execution of an agreement in respect of the modalities of the work to be done duly signed by him indicating his acceptance of the conditions that would be laid down in the agreement.

The quotation along with all requisite documents shall have to be submitted by 3:00 pm on 05th November, 2018 at the Chamber of the EVM Nodal Officer, Purulia and the same will be opened on 05/11/18 at 4:00 pm on the same day in the Chamber of the Additional District Magistrate (EVM), Purulia. No quotation shall be considered after expiry of scheduled date and time as specified hereinabove. Quotationers may remain present at the time of opening of the sealed envelopes.
